



## WAIVER & RELEASE

In consideration of the services of Camp Kodiak Inc., their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred as "Camp Kodiak"), I hereby agree to release and discharge Camp Kodiak, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that participating in camp activities entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or cause bodily harm to my son/daughter or to third parties, or damaging property. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of these activities.
2. I expressly agree and promise to accept and assume all of the risks existing in camp activities. My son/daughter's participation in these activities is purely voluntary, and s/he may elect to participate in spite of the risks.
3. I hereby release, forever discharge, and agree to indemnify and hold harmless Camp Kodiak from any and all claims, demands, or causes of action, which are in any way connected with my son/daughter's participation in activities or his/her use of Camp Kodiak's equipment or facilities, including any such Claims which allege negligent acts or omissions of Camp Kodiak.
4. I agree to indemnify and hold Camp Kodiak or anyone acting on their behalf harmless for all fees and costs relevant to enforce this agreement.
5. I hereby certify that my son/daughter has no medical or physical conditions, which could interfere with his/her safety in this activity.
6. The participants and parents agree to abide by the rules, regulations and policies set forth by the Camp.
7. The Camp reserves the right to dismiss any participant, whose conduct or influence it deems to be unsatisfactory or harmful to the best interests of the participant or the Camp.
8. While every effort will be made to return lost, misplaced or stolen property, the Camp shall not be held liable for these articles. Nor shall it be held liable for broken or damaged property.
9. The Camp has the right to use photographs and videotape of any participant in its promotional material.
10. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect. By signing this document, I agree to waive my right to file a lawsuit/claim against Camp Kodiak Inc.
