Arthritis Society Canada's Arthritis Awareness Month x Tenors Contest 2024 Prizing Terms & Conditions

ARTHRITIS SOCIETY CANADA'S ARTHRITIS AWARENESS MONTH X TENORS CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. THE CONTEST IS OPEN TO LEGAL RESIDENTS OF CANADA ONLY. DO NOT ENTER THIS CONTEST IF YOU ARE NOT A LEGAL RESIDENT OF CANADA. NO PURCHASE IS NECESSARY. THERE IS NO AGE RESTRICTION FOR PARTICIPANTS. THE FOLLOWING CONDITIONS MUST BE MET IF THE PARTICIPANT IS A MINOR; (1) A PARENTAL/LEGAL GUARDIAN MUST CONSENT TO THE MINOR'S PARTICIPATION IN THE CONTEST, (2) THE PRIZE MUST BE AWARDED TO THE PARENT/LEGAL GUARDIAN OF THE WINNER (AND NOT TO THE MINOR), (3) THE PARENT/LEGAL GUARDIAN MUST SIGN THE RELEASE FORM ON BEHALF OF THE WINNER. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

- a. be a legal resident of Canada, as per the applicable laws of Canada,
- b. if a minor (1) a parent/legal guardian must consent to the minor's participation in the Contest; (2) the prize must be awarded to the parent/legal guardian of the winner (and not to the minor); (3) the parent/legal guardian must sign the release form on behalf of the winner.
- c. The winner must sign the release form. Employees of Arthritis Society Canada's Prize Supplier, their affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members and/or the immediate family of any of the above, are not eligible to participate in the Contest. For the purpose of these Contest Rules, "immediate family" means husband, wife, spouse, common law spouse, mother, father, grandmother, grandfather, brother, sister, son and/or daughter, whether or not they reside in the same household.

Arthritis Society Canada shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Arthritis Society Canada for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. Arthritis Society Canada reserves the right to disqualify any entry or entrant at their sole discretion, should any entry or entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

2. DRAW PERIOD.

There will be 1 draw. Complete the online form between September 3 and October 12, 2024 and be entered into the draw. (The "Contest Period").

3. HOW TO ENTER.

There is no purchase necessary to enter the Draw(s). Complete the online form (https://arthritis.ca/action/arthritis-steals/what-has-arthritis-stolen-from-you) and be entered into the draw.

4. PRIZE.

- a. The draw will consist of a pair (2) of tickets to The Tenors' performance on December 4, 2024, and a one-night stay at Fallsview Casino Resort, 6380 Fallsview Blvd, Niagara Falls, Deluxe Queen Room (double occupancy) on December 4, 2024.
- b. The Prize will be delivered to the Winner directly from Arthritis Society Canada to the address provided by the Winner after the Winner has been successfully contacted and notified of their Prize and has complied with the Contest Rules.
- c. Prize must be accepted as awarded and cannot be transferred, substituted or redeemed for cash.

5. WINNER SELECTION.

Winners shall be selected as follows:

- a. After the deadline has passed for the "contest period" Arthritis Society Canada, located in Toronto at 220 Bay St, 3rd Floor, Toronto, ON, M5J 2W4 will conduct a data pull for all qualified participants. The list will be exported to a spreadsheet. The Winner(s) will be selected by a random draw from all eligible Entries received. The odds of being selected as a potential Winner are dependent upon the number of eligible Entries received. Before being declared a Winner, the selected potential Winner will be required to answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question during a pre-arranged telephone call or email and comply with the Contest Rules.
- b. THE SELECTED POTENTIAL WINNER WILL BE NOTIFIED BY EMAIL. Upon notification, the selected potential Winner must respond by EMAIL (and answer the skill testing question within the time frame listed above) with the address provided in the notification and the selected potential Winner's response must be received by Arthritis Society Canada within 30 days. If the selected potential Winner does not respond in accordance with these Contest Rules, they will be disqualified and will not receive the Prize and another potential Winner may be selected in Arthritis Society Canada's sole discretion. The potential Winner will be required to correctly answer a skill-testing question in order to claim the Prize and will have to respond to Arthritis Society Canada within 30 days. This skill-testing question will be mathematical in nature. A new winner will be selected via the above mentioned process if the winner does not respond within the time frame provided.

6. RELEASE.

The Winner will be required to execute a release ("Release") that confirms Winner's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of Arthritis Society Canada and its respective parent companies, subsidiaries, affiliates, employees, directors, officers, unit holders, suppliers, agents, and administrators (the "Releasee") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in this Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising there from; and (iv) grant to Arthritis Society Canada of the unrestricted right, in Arthritis Society Canada's individual discretion, to produce, reproduce, publish, broadcast, communicate by telecommunication, exhibit, distribute, adapt and otherwise use or re-use the Winner's name, photograph,

likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within two (2) business days of the verification as a Winner or the selected potential Winner will be disqualified and the Prize forfeited.

7. INDEMNIFICATION BY ENTRANT.

By entering this Contest, entrant releases and holds Releasee harmless from any and all liability for any injuries, loss or damage of any kind to the entrant, Releasee or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in this Contest, any breach of these Contest Rules, or in any prize-related activity. The entrant agrees to fully indemnify Releasee from any and all claims by third parties relating to the Contest, without limitation.

8. LIMITATION OF LIABILITY.

Arthritis Society Canada assumes no responsibility or liability for lost, late, misdirected or incomplete Entries, notifications, responses, replies or any Release, or for any telephone, hardware, software or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an Entry. Arthritis Society Canada is not responsible for any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. Arthritis Society Canada assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries. Arthritis Society Canada is not responsible for any problems, failures or technical malfunction of any telephone network or lines on account of technical problems or otherwise. Arthritis Society Canada is not responsible for any injury or damage caused to entrant relating to or resulting from participating in the Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any prize. Entrant further agrees to be bound by the decisions of Arthritis Society Canada, which shall be final and binding in all respects. Arthritis Society Canada reserves the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest; (c) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE RELATED TO THE CONTEST OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

12. TERMINATION.

Arthritis Society Canada reserves the right, in their sole discretion, to cancel, amend, modify or terminate all or any portion of this Contest at any time for any reason without prior notice.

13. LAW.

These are official Contest Rules. This Contest is subject to applicable federal, provincial and municipal laws and regulations. These Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over Arthritis Society Canada unless you are a Quebec resident in which case the law applicable in Quebec shall apply. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and Arthritis Society Canada in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.

14. LANGUAGE.

In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
